Day 1---Away we go!!! Sit back and relax as we make our way to our Nation's Capitol. Dinner is included this evening.

Day 2--- After breakfast at the hotel, depart for a full day of touring. Stop at **Arlington Cemetery** to meet our guide for a tour via tram. Arlington is the final resting place for several members of the Kennedy Family including president John F. Kennedy. You will also see the **Tomb of the Unknown, Wreath-Laying Ceremony and the Space Shuttle Challenger Astronauts Memorial**. A stop will be made at the **Marine Corps War Memorial's Iwo Jima Statue**. Afterwards, head for the **Capitol Visitor Center** and enjoy lunch on your own in the cafeteria, then visit the **US Capitol and the US Library of Congress** and the outside of the **Supreme Court Building**. Later, you will arrive at the National Mall to visit the **World War II Memorial, The Vietnam Veterans Memorial the Lincoln Memorial, and the Korean War Veterans Memorial**. Dinner is included this evening. Your day will end with a tour of the **Air Force Memorial and the Pentagon 9/11 Memorial Park**.

Day 3---Following breakfast, be one of the first to see the new **Museum of the Bible** which provides guests with an immersive and personalized experience as they explore the history, narrative, and impact of the Bible. Enjoy lunch on your own in the area and meet your guide for a driving tour which passes along **Embassy Row** and includes a tour of the **Washington National Cathedral** and a visit to the **Smithsonian's National Museum of American History and/or other Smithsonian Museums**. After dinner (included), we will depart on a driving tour of some more illuminated monuments. Stops will be made at the **Martin Luther King, Jr., Memorial, the Jefferson Memorial and the FDR Memorial**.

Day 4—Breakfast included at hotel. Off we go to visit the **National Museum of the Marine Corps** in Quantico. Followed by a visit to **Mount Vernon, the home of George Washington**. Spend time viewing the house and grounds of the "Father of Our Country". You will also have time for lunch on your own while visiting. Later in the afternoon, you will visit the **Smithsonian's Steven F. Udvar-Hazy Air and Space Museum** located at Dulles Airport. The Museum houses many aircraft/spacecraft which tell the history of aviation and space flight. You will also see the newest arrival, the Space Shuttle Discovery, which was the longest serving orbiter in the NASA space shuttle fleet. Dinner is included.

Day 5—Breakfast at hotel. Indiana....here we come!!
