**Day 1.....All Aboard as we travel to Madison, IN. Upon arrival, we will be greeted by a step-on-guide who will give as a one hour driving tour of this quaint riverboat town that includes three National Historic Landmarks and 133 blocks on the National Register of Historic Places. After the tour, we will have some free time to explore on own. Late afternoon we will check-in to Clifty Falls Inn. (Double Beds Only At This Property). Dinner is included on property at Falls Restaurant. Take time to enjoy the sun porch overlooking the Ohio River. Those who are adventurous might want to take a hike and explore. (D)**

**Day 2....Today we board the *Belle of Louisville*. This is the perfect time of year to see all the beauty offered along the banks of the Ohio River. Enjoy a leisurely cruise to Louisville that includes entertainment, games, full hot lunch buffet and popcorn throughout the cruise. Since her berth in 1914, the *Belle of Louisville* has taken over 7 million people for a cruise on America's inland waterways. The *Belle* is America's last true Mississippi River steamboat still in operation, and turned 100 years old in October 2014. Guests are welcome to tour the engine room and enjoy the fall colors. At dusk, we will visit the *Jack-O-Lantern Spectacular*—over 5000 intricately carved pumpkins over a ¼ mile walking trail. Each jack-o-lantern is totally different and illuminated at night as an art show. Experience the glow of thousands of pumpkins, set in a magical display of artistry during this nighttime *Spectacular* and feast your eyes on thousands of artfully carved jack-o-lanterns depicting people, places and scenes from popular culture to old-time favorites and everything in between....all with painstaking detail and amazing intricacy. **Day 3...This morning we will meet a local guide who will give a history of Louisville.....Ghost Tour of Old Louisville. Often called the original Sin City, Louisville offers stories of love on the rocks, money and fame won and lost, a collection of architecture that will wow you. Secrets hide within Old Louisville, as do the spirits that refuse to vacate homes. Experience a narrated tour through Louisville's first suburb....sit back and enjoy a ghostly tale from a local performer and discover the hidden charms of Floral Terrace, where a phantom from the Great Depression still lingers in the shadows. See where tobacco barons and bourbon kings made their homes. Tour also includes Happy Balls! The homemade bourbon balls from Old Louisville. Our tour continues to the Conrad-Caldwell House. Upon arrival guests will be greeted with a delicious welcoming beverage of goblin spit or beetle juice before making our way to an opening performance by the ghosts of the Conrad-Caldwell House. Finish the tour following in the "footsteps" of the Ghosts of The Conrad-Caldwell House as they take us on a tour through the mansion and share their favorite haunts throughout the historic Richardsonian Romanesque home. Lunch is included before we depart for a tram ride at the Mega Caverns located beneath the Louisville Zoo. The caverns were created by a massive underground limestone quarry during the middle of the last century. Temperature is a constant 58 degrees so bring your jacket! Time to leave and head home as we once again travel through the brilliantly colored Indiana countryside. (B,L)**
