### DAY 2

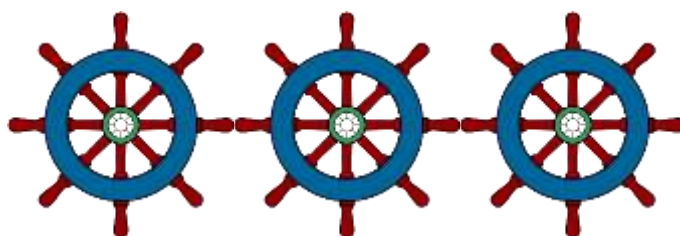
