<u>DAY 3</u>...Enjoy breakfast, then board motorcoach and head for Pier 83 in Midtown Manhattan where you will board the <u>Circle Line Ferry</u> to glide down the Hudson River passing several well-known New York City landmarks such as Hudson Yards, the One World Trade Center, Empire State Building, Chrysler Building and finally the <u>Statue of Liberty</u>. The Statue was an international gift of friendship from the people of France to the people of the United States. After your ferry ride, depart for the <u>Intrepid Air & Space Museum</u>, an American military and maritime history museum featuring the legendary aircraft carrier Intrepid, the space shuttle Enterprise, the world's fastest jets and a guided missile submarine. Later, depart for dinner at another popular restaurant, followed by another fabulous **Broadway Show**. B,D

Day 4...After breakfast, travel into New York City to meet your guide for a Tour of Lower Manhattan. The tour includes the famous buildings and colorful districts such as Times Square, Greenwich Village, Little Italy, Chinatown, The Garment District, The Financial District and Ground Zero.
