NORTH CAROLINA OUTER BANKS ADVENTURE

DAY 1.....All Aboard! Travel to Beckley, WV for the night. Dinner included. (D)

DAY 2....Outer Banks.... here we come. Check into Hilton Garden Inn, Kitty Hawk, NC. Dinner included. (B, D)

DAY 3...Meet guide to begin our adventure. First stop is Wright Brothers Park and Memorial. The Visitor Center is home to a museum featuring models and actual tools and machines used by the Wright brothers during their flight experiments including a reproduction of the wind tunnel used to test wing shapes and a portion of the engine used in the first flight. This is where Wilbur and Orville Wright made the first powered airplane flight. The Visitor Center offers a full-scale replica of the original plane - the "Wright Flyer", and talks on the history of the Wright Brothers. Exhibits and a conducted trip to grounds which includes the Wrights' 1902-1903 camp buildings will also be included in tour. We will then depart for the village of Manteo on Roanoke Island Lunch on own and free time in downtown historic Manteo. Time to depart for tour of the Elizabeth II, a representative of a 16th century sailing ship. You'll meet sailors like those who sailed across the Atlantic in 1585. Dressed in period garments and speaking Elizabethan dialect, these interpreters bring the history of the voyages to life. At the Settlement Site, you will encounter soldiers bravely facing the challenges of the New World. By viewing the film The Legend of Two Paths, you'll find out how the 1584 arrival of the English changed the life of the native Roanoke Island population, the Algonquians. In the Roanoke Adventure Museum, you will find interactive exhibits exploring the 400 years of Outer Banks history since America's beginning. You can spot a star with an astrolabe, meet the Algonquians through John White drawings, climb aboard a skiff and hoist her sails, meet a pirate who sailed with Blackbeard, learn about the lighthouses and lifesaving, experience duck hunting and take a shopping trip to a 1900s general store. Next up is Johnny's Dolphin Cruise. You will hear a factual narration on the Bottlenose Dolphin. Dolphin mating and birthing observed on many cruises. See the most respected aquatic mammal in its natural habitat. Dinner included. Guests may want to take a beach walk and enjoy the sunset after returning to property. (B, D)

DAY 4...After breakfast, depart for **Wild Horse Tour**. The tours embark from Corolla NC, the last Outer Banks outpost before the road ends into nothing but stretches of wide beach. You will see the Wild Horses, descendants of the Spanish Mustangs brought to the New World by explorers as long ago as the early 1500s. Because we go to their native habitat, you have the chance to experience much more than just a tour to see these majestic beings; you also get stories about the history of this area, a chance to learn about the other wild animals and vegetation of this area...and sometimes even a pirate tale or two! The guides are entertainers as well as expert horse spotters, and they know how to keep you engaged and interested. View the horses in an open-air Safari-style vehicle. Next, we will enjoy a stop at the **Currituck Beach Lighthouse** which is the only lighthouse open for climbing. Built in 1874 this is the lighthouse in its original structure. Depart for lunch own at Timbuck II shopping area. Return to property for FREE time at the beach or pool. Dinner included. (B, D)

DAY 5...Time to explore! First stop is the **Chicamacomico Life Saving Station.** As part of your admission, you can expect to be greeted and given a brief synopsis of the history of the US Life Saving Service and its relation to the station and site. You will be shown a video of the station's history and given a tour brochure providing an explanation of how to access the 5 exhibit buildings on site. Dozens of courageous rescues took place at Chicamacomico between 1874 and 1954. Both stations, the 1874 and the1911, which replaced it were built to withstand storms, shifting sand, the ravages of time and to provide a safe haven for lifesaver and wreck victims. The Chicamacomico site is lovingly preserved and today provides a window into the history of the ordinary and heroic lifesavers of the Outer Banks. Lunch included today. Depart for **Cape Hatteras Lighthouse**. This is the tallest brick lighthouse in the U.S. Moved back from the ocean in 1999 to protect it from beach erosion; the lighthouse is a national treasure. See the sport fishing vessels come in from the Gulf Stream at the Oregon inlet Fishing Center. It's full of excitement as the fish are tossed out on the dock. NO CLIMBING due to renovation. Next stop, **Bodie Lighthouse**. This light house had the rockiest of beginnings. Disagreements over the location delayed the building of the first lighthouse for ten years. Dinner included. (B, L, D)

DAY 6...Time to say "Good Bye" to the Outer Banks. Depart for Mt. Airy, NC. Enjoy a 30-minute ride in authentic period **squad cars.** We'll start off at the famous Wally's Fillin Station, then take a ride down main street and check out all the sites like Barney's Café and Floyd's Barber shop and then we'll swing by Andy's original homeplace. This and much more can be seen while taking a trip through the past. If you are a true Andy Griffith fan then this tour is a must. Where else will you ever get the chance to ride in a Mayberry squad car. A visit to the **Andy Griffith Museum** is also included. The Museum is a place both for learning about and celebrating Andy Griffith, who was born in Mount Airy in 1926. Home of the single largest collection of artifacts and memorabilia related to Andy Griffith, the museum features hundreds of items from Andy's life and his career in theater, film, and music. Highlights of the collection include actual props, wardrobe, and other artifacts from The Andy Griffith Show and Matlock that were donated by Cindi and Andy Griffith, members of the casts and crews, and other individuals and organizations. Dinner included. (B, D)
