<u>DAY FOUR</u> - Depart for a moving experience at Section 22 of Quantico National Cemetery, where the <u>Missing in America Project</u> honors the memory of veterans. Pay your respects with a private flag laying ceremony at the graves of veterans whose remains were previously forgotten. Your group will hear from a MIAP volunteer about the time-consuming process identifying the veterans, as well as show you how to distinguish between the Missing In America Project veterans and their comrades in the cemetery. Depart for an inspiring visit to the **National Museum of the Marine Corps**, a beacon of honor and valor nestled in Quantico, Virginia. Immerse yourself in the captivating exhibits and interactive displays that pay tribute to the bravery, sacrifice, and unwavering commitment of America's finest warriors. While here, the group will enjoy lunch on their own in the museum café. Depart for our nation's capital and settle into your conveniently located hotel. Dinner this evening will be at Tony & Joe's Seafood Place a well-known restaurant located in Washington, D.C., situated along the waterfront of the Potomac River. (B, D)

Over the years, it hosted numerous notable figures, including George Washington, Thomas Jefferson, and John Adams, making it a hub of political and social activity during the early days of the United States. (**B**, **D**) **DAY SIX** –Bid farewell to Washington, DC, making a stop at the **Steven Udvar Hazy Center** which displays thousands of aviation and space artifacts, including the Space Shuttle Discovery, a Blackbird SR-71, and a Concorde, in two large hangars. We will also have time to experience the Airbus IMAX Theater. Overnight in Bedford, PA. Dinner on own. (B)
